Commercial Deliveries of Inmarsat Docking Stations Commence

Beam Communications Pty Ltd, a wholly owned subsidiary of World Reach Limited, today announced that it has completed the development phase of the docking solutions and has now commenced commercial shipping of its first Inmarsat-based products.

The Final Acceptance Tests completed in July provided the go-ahead to commence manufacture of commercial quantities of the Beam IsatDock docking units. The four docking solutions target specific market applications when used in conjunction with Inmarsat's latest global handheld satellite telephone, IsatPhone Pro.

Utilising Beam's expertise from the development of several other docking solutions, the company has successfully completed the development phase of the project, which commenced in January of this year and has been completed on schedule and within budget.

Inmarsat's Chief Operating Officer, Perry Melton, said: "Inmarsat is extremely pleased with Beam's commitment to developing this unique range of solutions for our first handheld satellite handset. The initial feedback from our global distribution partners has been extremely positive and we are confident the IsatPhone Pro handset and Beam's IsatDock will be a successful combination."

This has been a very exciting opportunity for Beam to partner with Inmarsat for the launch of the IsatDock solutions. Prior to the release of the first shipments there was in excess of \$0.5M of pre-orders from several of Inmarsat's strategic distribution partners.

Sales of the Inmarsat docking units are expected to ramp up over the coming months as volumes of the IsatPhone Pro handhelds penetrate global markets and sales of IsatDocks are anticipated to exceed US\$7M over the initial two-year period.

Beam's docking stations bring extra features to Inmarsat's IsatPhone Pro global satellite handset. Four specific models of the docking station have been released - the IsatDock MARINE, IsatDock PRO, IsatDock DRIVE and IsatDock LITE.

The benefits of using the new IsatDocks include:

- Automatic charging while docked ensures IsatPhone Pro is always ready for use
- Audio quality of a standard telephone, via the handy speakerphone, headset, or an additional handset, providing more privacy for calls
- IsatPhone Pro can be conveniently positioned using long distance cables between the dock and the antenna
- An intelligent Plain Old Telephone System (POTS) interface, enabling the use of standard telephone equipment - including integration to a PABX user with access to specialised tracking and emergency alert functions
- Easy access to data services – from next year, IsatDocks will provide easy access to new IsatPhone Pro data services.
