Notice under section 708A(5)(e) of the Corporations Act 2001

On 18th October 2010, Austbrokers Holdings Limited (**Austbrokers**) issued 924,835 ordinary shares (**Shortfall Shares**) at an issue price of \$4.9365 per share to Goldman Sachs and certain other sophisticated and professional investors under the terms of the dividend reinvestment plan shortfall underwriting agreement entered into with Goldman Sachs on 28th September 2010.
