 - 5. The Company has recently completed a private capital raising through the issue of convertible notes, raising in aggregate \$800,000. These raisings were announced to the market in ASX announcements dated 11 and 28 October 2010. The first of these tranches has been included within the resolutions being put to shareholders for approval at the AGM in November.
 - Over the period to October 2010 the Company completed the convertible note issue, developed a new export market in the Middle East, and further reduced its monthly cash burn rate. With the convertible note funds raised recently, developing but lumpy export market sales, and approximately \$600,000 in funding owing by the Australian Government, the Company has funding sources sufficient to see the Company through to breakeven. Until breakeven occurs, which the Board expects to occur during the second half of financial year 2011, should the Company require further working capital over and above the funds referred to above, these funds will be raised from investors and parties who have been long term supporters of the Company. In the interim the management of the Company will continue to reduce operational costs and further reduce the monthly cash burn. The monthly cash burn has fallen significantly since listing in August due to the non-repetitive nature of numerous of the expenses that were associated with the IPO.

7. At the end of the last reporting quarter (30 June 2010) the Company disclosed a net end of quarter cash position of -\$296K. This comprised the overdraft facility with the CBA of -\$299K and cash on hand with the Company's new bankers NAB \$3K. At the end of June, the CBA facility was closed and the amount transferred to unsecured borrowings. Accordingly, the company operates without any bank facility, and over the past two months to 28 October under a commercial settlement reached with the CBA bank, has reduced this unsecured borrowing by \$200,000. This consolidated statement of cash flow therefore reflects the Company's operating cash position exclusive of the previous overdraft facility held with the CBA.
