Abacus Property Group (Group) confirms that at its Annual General Meeting held on 12 November 2010 securityholders approved the resolutions to consolidate the Group's issued capital. Every 5 preconsolidation stapled securities will be consolidated into 1 post-consolidation stapled security.

As a result, the number of stapled securities on issue will reduce from 1,851,992,381 to approximately 370,398,000. The exact number of stapled securities on issue will depend upon the rounding of fractional amounts. Not all securityholders will hold a number of stapled securities that can be divided evenly by 5. Where a fractional entitlement occurs, those fractions are to be rounded up to the nearest whole stapled security.

The Group confirm that that the consolidation does not involve a return of capital to securityholders and accordingly there is no direct impact on the Group's market capitalisation or book value of paid up capital.

In line with the consolidation timetable outlined in the Explanatory Memorandum of the Notice of Meetings dated 12 October 2010 and detailed on the next page of this announcement, the Group's stapled securities will trade on a deferred settlement basis from 16 November 2010 to 29 November 2010. During this time the Group's ASX code will change to ABPDA. The Group will trade on a normal settlement basis from 30 November 2010 under its original ABP code.

Securityholders are not required to take any action in relation to the consolidation, and will be sent a new holding statement on 29 November 2010 indicating the new number of stapled securities they hold.
