### CALTEX AUSTRALIA LIMITED BOARD AND ALTERNATE DIRECTOR CHANGES

Mr Timothy (Tim) Leveille has been appointed as a director of Caltex Australia Limited (Caltex) with effect from 1 December 2010 to fill a casual vacancy on the Board. Mr Leveille's appointment follows the resignation of Mr Rob Otteson, who has resigned as a director with effect from 30 November 2010.

Mr Leveille has over 20 years of experience in the oil and gas industry working for Chevron. Chevron Corporation, through a group company, holds 50% of the ordinary shares in Caltex Australia. Chevron is one of the world's leading global energy companies.

Mr Leveille is the Senior Director – International Finance in Chevron's Corporate Treasury and is based in the US. In this role, he is responsible for treasury oversight and support for the finance activities of Chevron operating companies in the Americas, Asia Pacific and Global Businesses, and for global intercompany financing and cash repatriation activities. His experience encompasses a range of financial management roles across a number of Chevron companies in the US and internationally.

The Board has determined that Mr Leveille is not an independent director due to his service as an executive with Chevron.

The Board has approved Ms Jones-Cervantes' appointment as an alternate director for Mr Leveille with effect from 1 December 2010. As a result of Mr Otteson's resignation, Ms Colleen Jones-Cervantes' appointment as his alternate director automatically ended on 30 November 2010.
