DRILLING REPORT – 9 December 2010

WELL NAME: Mananda 5, PNG

Oil Search reports that as at 0600 hrs PNG time (-1 hr AEST) on 9 December, Mananda 5 was at a depth of 1,830 metres. During the week, the 11- $\frac{3}{4}$ " liner was set and preparations are underway to drill ahead towards the primary Toro and Digimu reservoir objectives. Drilling progress for the week was 159 metres.

Mananda 5 is located in PPL 219, approximately 25 kilometres north west of the SE Mananda and Agogo oil fields. The well is targeting the Toro, Digimu and Iagifu sandstones in the seismically defined Mananda Attic hanging wall anticline. The mean success case volume is 30 million barrels recoverable.

The well has a planned total depth of approximately 2,700 metres. Subject to results, Mananda 5 may be deepened to evaluate the Koi-Iange sandstone and constrain an underlying footwall target.

DRILLING REPORT – 9 December 2010

WELL NAME: Al Meashar-2, Block 7, Yemen

Oil Search reports that as at 06:00 Yemen time on 8 December (-8 hrs AEST), the Al Meashar-2 well in Block 7, Yemen was at a depth of 3,017 metres in the Meem Member of the Madbi Formation and drilling ahead. Progress for the week was 37 metres.

Al Meashar-2 is an appraisal well of the Al Meashar-1 oil discovery made in early 2010. The well is being drilled from the existing Al Meashar-1 well pad using Managed Pressure Drilling to minimise damage from drilling fluids in the reservoir. The planned total measured depth of the well is approximately 3,740 metres.
