Praemium drives US tax-compliant portfolios for US investors

"The Inland Revenue Service (IRS) has significantly increased the pressure on US citizens residing in the UK and Europe, with many having to fill out a number of other time-consuming forms and the problem has become a wider issue for the wealth management community in the UK," he said.

"With this in mind, London & Capital has launched the fund range of portfolios, depending on the status of the US citizens.

"For those who have been living in the UK for less than seven out of the last nine years, there are three exchange traded fund (ETF) portfolios, ranging between the Conservative, aiming for a return of 4% to 6%; Balanced, which looks for growth between 7% to 9%; and an Aggressive Growth portfolio, looking for a return in excess of 10%.

"For US citizens who have been living in the UK for more than seven out of the last nine years, London & Capital has launched two Balanced portfolios, which are in direct stocks and bonds. Both sets of portfolios are in dollars and sterling."
