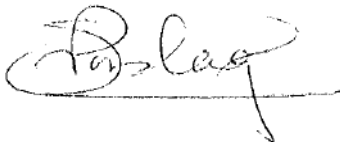

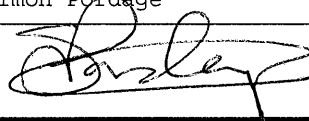

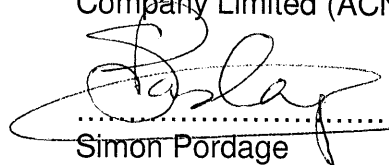

DIRECTIONS
