EXERCISE OF OPTIONS AND SHARE ISSUE

Exco Resources Ltd (**ASX: EXS**) (**Company**) is pleased to advise that 1,650,000 options at 27.3 cents have been exercised raising a total of \$450,040.

In addition the Company has issued 400,000 shares as payment of fees in relation to consultancy services received in respect of the White Dam Gold Project.

The funds will be used to proactively advance the Company's portfolio of copper projects in north-west Queensland, and for working capital and general corporate purposes.


