Background to the Offer

Senex and Stuart jointly announced Senex's offer on 21 February 2011 to acquire all Stuart shares for consideration of 2.5 Senex shares per Stuart share. The offer was recommended by all Stuart directors and its major shareholder. By the time Senex's offer closed at 5.00 pm Tuesday 12 April 2011, Senex had received acceptances for more than 92% of Stuart shares. On 13 April 2011 Senex lodged with ASIC and ASX a copy of its formal notice to compulsorily acquire all remaining Stuart shares for the same consideration, and that notice has since been despatched to all holders of the remaining Stuart shares.
