A typographical error appeared in two places in the announcement titled "Coal seam gas appraisal underway in CSG tenement ATP 547P in Queensland's Surat Basin" which Senex Energy Limited lodged with ASX Company Announcements this morning.

In the title of the announcement and in the first paragraph the exploration permit was incorrectly identified as ATP (Authority to Prospect) 547P.

The correct identification of the permit is ATP 574P.

Senex has no interest in ATP 547P.

The permit references in the last three paragraphs of the announcement correctly identified the relevant permit as ATP 574P.

Coal seam gas appraisal underway in CSG tenement ATP 574P in Queensland's Surat Basin

Release Date: 23 May 2011

Senex Energy Limited (Senex) and joint venture partner QGC – a BG Group business (QGC) have made good progress on the coal seam gas appraisal program in ATP 574P, with Peebs-14 intersecting 43 metres of net coal.

Peebs-14 is the second well to be drilled in the tenement during this current campaign, with appraisal well Pinelands-11 completed during April 2011.

Both wells having intersected substantially more net coal than in other regions of the eastern Surat Basin.

ATP 574P is located in the prime Walloons coal seam gas fairway on the eastern side of the Surat Basin, north-west of QGC's productive Berwyndale South coal seam gas field.

QGC, the Operator for ATP 574P, has advised Senex that the Peebs-14 well reached a total depth of 1,150 metres on 12 May 2010. Since then the well has been geophysically logged and four drill stem tests conducted on the well with two addressing the Taroom Coal Measures and two focused on the Juandah Coal Measures. Production casing has now been run and cemented in the well.

Senex holds a 30% interest in ATP 574P.
