### Compulsory acquisition of your Rabinov Trust units

As you may be aware, Growthpoint Properties Australia Limited ACN 124 093 901 in its capacity as responsible entity for Growthpoint Properties Australia Trust ARSN 120 121 002 (**Growthpoint**) has a relevant interest in more than 90% of the units in Rabinov Property Trust ARSN 099 776 342 (**Rabinov Trust**) as a result of its takeover bid.
