### Renounceable rights offer to raise up to approximately \$102.6 million

On 21 June 2011, Growthpoint Properties Australia (**GOZ**), announced an equity capital raising of up to approximately \$102.6 million by way of a 1 for 4.4 renounceable rights offer of approximately 54 million fully paid new ordinary stapled securities.

The record date for the entitlement offer was 7.00 pm (Melbourne time) on Wednesday, 29 June 2011. The offer is open to securityholders at the record date whose registered address is in Australia or New Zealand (and who are not otherwise ineligible to participate).

We regret that you are not eligible to participate in the rights offer. Consequently, arrangements will be made by GOZ to sell your rights on your behalf. The net proceeds (if any) from the sale of your rights under the rights offer will be sent to you. Please refer to the offer booklet (available on the Australian Securities Exchange website at www.asx.com.au) for further details.

Any sale of your rights will be made at prices and otherwise in such a manner as GOZ may determine. Interest earned on the proceeds of the sale of your entitlements will be applied against the expenses of the sale, including brokerage. GOZ will not be liable for any part of your rights which are not sold, or sold at any particular price. If GOZ determines (in its sole discretion) that there is no viable market for your rights, the rights will lapse and the associated new stapled securities will be available to eligible securityholders who have applied for additional stapled securities.
