## BEAM LAUNCHES 'TERRA' PRODUCTS FOR INMARSAT ISATPHONE LINK SERVICE

Beam Communications Pty Ltd, a wholly owned subsidiary of World Reach Limited, today announced that it has received Type Approval from Inmarsat plc for the launch of new land-based terminals.

In 2010 Inmarsat partnered with Beam Communications for the development of a new range of land and marine terminals to support Inmarsat's Global Satellite Phone Services. Inmarsat recently introduced a new service targeted for fixed land applications, IsatPhone Link, which is targeting several of its core market sectors such as oil & gas, mining, construction, utilities and aid.

The new Beam land-based terminals, known as the Terra 400 & 800, will provide voice capabilities, email and low-speed data services to core market sectors that operate in remote areas where there is limited terrestrial services.

Terra 400 is a dust and splash proof terminal allowing standard telephone handsets to be used for indoor applications whilst the Terra 800 is more advanced with a water resistant IP rating, inbuilt handset speaker phone, SMS and phonebook functionality and additional exterior SIM slot for multiple users, as well as the ability to integrate to PABX phone systems. Both products provide data access via USB.
