Rincon-1 New Oil Field Discovery.

Cooper Energy is pleased to announce that Rincon-1 in PEL92 has made a new oil field discovery.

Wireline logs and formation pressure tester have confirmed that Rincon-1 has discovered a 5 metre gross (4.5 metre net) oil column in the Namur sandstone. The pre-drill estimates (0.55¹ million barrels of P50 Prospective Resources) will be re-estimated after the productive performance of the well has been observed.

Rincon-1 will be completed as a PEL92 production well and be tied into the PEL92 production system that exports oil via the Callawonga to Tantanna flowline.

The next well in the PEL92 drilling program is Elliston-1 and information on that well will be made at the appropriate time.

Joint Venture Participants are Cooper Energy (25%) and Beach Energy (75% and Operator).
