CORRECTION: EXERCISE OF LISTED OPTIONS

In relation to the Company's previously lodged Appendix 3B in respect of the conversion of options exercisable at \$0.30 each and expiring 21 July 2011 (**NMGO**), the following correction is noted.

On 27 July 2011, a total of 13,638,717 NMGO were converted to fully paid ordinary shares, not 13,676,217 as was disclosed in the Appendix 3B dated 28 July 2011. The overstatement of 37,500 shares arose through an inadvertent duplication of an option exercise notice and payment, and the matter has been rectified.

An Appendix 3B disclosing the correct number of options converted and subsequent issued capital of the Company follows this announcement.
