URBAN AREAS OFF LIMITS TO MINING EXPLORATION - MINIMAL IMPACT TO QBL OPERATIONS

On the 15th August 2011 the Premier and Minister for Reconstruction The Honourable Anna Bligh and the Employment, Skills and Mining Minister The Honourable Stirling Hinchliffe issued a joint statement saying:

"No mining exploration will be allowed in and around urban areas of Queensland, including regional centres such as Ipswich, Toowoomba, Beaudesert, Rockhampton, Mackay and St George and an exploration Restricted Area would be declared over land bounded by the South East Queensland Regional Plan as well as other regional centres and towns with a population of 1,000 after a new policy was considered by Cabinet.

The restriction will cover existing exploration permits as well as future permits in these areas and means there will be no more exploration activity on urban land or within a two kilometre buffer of urban land. Ms Bligh said the Government would take feedback on the draft legislation to enshrine the changes which are expected to be in place later this year.

The legislation preventing development in urban areas will be in place later this year but companies that want to relinquish the relevant sub-blocks of their tenure before then will have an incentive to do so. Companies that voluntarily relinquish tenure now will have it accredited towards their next relinquishment obligations.

The buffer zones that will impact QBL's operation are planned to be placed around Toowoomba, Childers, Innisfail, Gayndah, Wondai, Kingaroy, Murgon, Mareeba and Atherton. In total the buffer zones will account for <1% of the total combined project areas with a high percentage of the buffer zones outside QBL Projects.

The affected areas are not the primary focus of our current drilling campaigns, nor are they considered primary target exploration locations.

QBL will monitor the progress of the legislation and will continue to maintain dialogue with the Queensland Government to determine those blocks that will likely be affected by proposed future drop-off requirements for portions of the project within 2km of urban areas, to ensure the long term protection of QBL's interests.




Kingaroy-Childers Project showing 2km buffer zones around major regional population centres
