News Release

MAJOR NICKEL INTERSECTION BELOW FLYING FOX MINE.

The Board of Western Areas is pleased to announce outstanding results from recent drilling below the Flying Fox and Spotted Quoll mines. Current drilling programs are designed to support the short term goal to lift mine life at both Flying Fox and Spotted Quoll to 10 years.

At **Flying Fox**, recent drilling has intersected high grade massive sulphide in the T6 deposit, approximately 100m below the large T5 deposit where mine development is in progress. Initial results from T6 include an intersection in drill hole FUG692 of **34.7m of massive sulphide with an estimated average grade of 7% nickel**. Formal assays are required to confirm the nickel grades which have been estimated using a portable XRF analyser (Niton).




Figure 1: Recent High Grade Intersections within Flying Fox T6 and T7 Zones

The intersection in FUG692, which has an interpreted true width of 9m, is hosted in a pegmatite lode at approximately 1200m vertical depth, 120m below the Western Areas' decline. FUG692 is supported by four other high grade intersections along a minimum 150m strike length in the T6 (Figure 1). There is currently no mineral resource estimate for T6.

At **Spotted Quoll**, recent drilling below the Stage One Ore Reserve (where mine development is in progress) is continuing to produce high grade intersections. Three surface drill rigs are testing Stage Two between 450m to 1,000m vertical depth. Assay results from a number of drill holes are awaited however results include an intersection in drill hole WBD181W2W2W2 of **3.3m** @ **8.3%** nickel near the southern boundary of the Stage Two deposit (refer previous releases). An initial Mineral Resource estimate for Stage Two is expected in the December Q.

A scoping study is underway to review the potential to increase production from the Spotted Quoll underground mine from the current 10,000tpa rate outlined in the feasibility study to a new target of up to 15,000tpa nickel in ore. First ore from the Spotted Quoll underground mine is expected to be mined in December.

Discussion

Managing Director Mr Julian Hanna said "These results are providing encouragement on the potential for Western Areas to reach its short term goal of extending mine life at both Flying Fox and Spotted Quoll. Drilling within T6 and in the underlying T7 deposit at Flying Fox and in Stage Two at Spotted Quoll is ongoing. The aim of this drilling is to achieve a significant upgrade in mineral resources at both mines within the next few months."

Mr Hanna added, "Western Areas' medium term goals include making new nickel discoveries at Forrestania, at Sandstone, and at exploration projects in Canada and Finland. We have been very active on these projects during the September Q and a separate release outlining some exciting exploration results from these areas is expected in the next week".
