MONADELPHOUS CONTRACTS UPDATE

Leading engineering group Monadelphous Group Limited (ASX: MND) ("Monadelphous" or "the company") today announced it has secured construction and maintenance contracts with a combined value of approximately \$230 million. The contracts are with major customers across Australia in the resources, energy and infrastructure industry sectors.

Major new contracts awarded comprise the following:

- Structural, mechanical, piping, electrical and instrumentation works for the upgrade of the coal
 preparation plant and stockyards as part of the extension project at the Rio Tinto Coal
 Australia-managed Kestrel Mine near Emerald, Queensland. This follows two contracts
 announced in August for installation of conveyors at the extension project.
- Construction and commissioning of coal conveyors associated with Xstrata Coal's Ulan West Project in the central west of New South Wales.
- Structural and mechanical works associated with the coarse ore stockpile at Cape Lambert for Rio Tinto Iron Ore in Western Australia.
- Construction of the Toowoomba Wastewater Infrastructure Projects program for the Toowoomba Regional Council in Queensland. This contract was secured in joint venture with Transfield Services (Australia) Pty Ltd and includes new sewage pump stations, pressure and gravity sewer mains, and a sludge clarifier at the Mt Kynoch Water Treatment Plant.
- Construction of the onshore DomGas Pipeline for Clough Sea Trucks Joint Venture associated with Chevron Australia's Gorgon LNG Project in Western Australia.
- A two-year extension to an onshore maintenance and shutdown services contract with ConocoPhillips Australia at its Darwin LNG facility in the Northern Territory.

All construction contracts are scheduled for completion in the second half of the 2012 calendar year.

These awards confirm the emerging pipeline of opportunities in all markets and bring the total value of new work secured by Monadelphous in the first half of the financial year to approximately \$730 million.

"The contracts reflect our broad market coverage and our ability to deliver a diverse range of services to quality customers," Monadelphous Managing Director Rob Velletri said.
