MONADELPHOUS CONTRACTS UPDATE

Leading engineering group Monadelphous Group Limited (ASX: MND) ("Monadelphous" or "the company") today announced it has secured construction contracts in Australia and Papua New Guinea in the resources and infrastructure industry sectors. The contracts have a combined value of approximately \$140 million.

New construction contracts comprise the following:

- Structural, mechanical and piping works for the supply and installation of the screenhouse for Rio Tinto Iron Ore at its Cape Lambert Port B Project in Western Australia. This contract is scheduled for completion by the first quarter of the 2013 calendar year. The project follows the recently completed deconstruction works and the recently awarded coarse ore stockpile project also at Cape Lambert.
- Two contracts for Unitywater at its Cooroy and Woodford Sewage Treatment Plant Augmentation projects in Queensland. These projects are scheduled for completion before the end of the 2012 calendar year.
- Pipeline remediation works for Ok Tedi Mining in Tabubil, Western Province in Papua New Guinea (PNG). The contract has been secured by Monadelphous's KT Pipeline Services and follows previously successful pipeline projects completed for Ok Tedi Mining in PNG. This project is scheduled for completion by the first half the 2012 calendar year.

The awards bring the total value of new work secured by Monadelphous in the 2012 financial year to \$870 million.

"These contract wins continue to underpin strong revenue momentum and reflect the growing diversification of our quality customer base," Monadelphous Managing Director Rob Velletri said.
