#### SUBSTANTIAL SECURITY HOLDER - CHORUS LIMITED

- 1. We **enclose** a substantial security holder notice by Telecom Corporation of New Zealand Limited ("**Telecom**") in respect of Chorus Limited ("**Chorus**").
- 2. Chorus is currently a wholly-owned subsidiary of Telecom and has 100 ordinary shares on issue. Telecom acquired the ordinary shares in Chorus upon Chorus' incorporation on 1 July 2011.
- 3. Although the demerger of Chorus by Telecom is not scheduled to complete until 30 November 2011, the official quotation and deferred settlement trading of Chorus ordinary shares commenced on the ASX on 21 November 2011 and on the NZSX today.
- 4. As a result of the above, the substantial security holder notification regime under the Securities Markets Act 1988 (New Zealand) has commenced in respect of Chorus. Telecom is filing a substantial security holder notification because Telecom will hold legal and beneficial title to all of the ordinary shares in Chorus until the demerger of Chorus by Telecom on 30 November 2011. Following the demerger, Telecom will not hold a relevant interest in Chorus shares.
