## **ACQUISITIONS – SUNSHINE COAST**

1300SMILES Ltd has completed due diligence on two dental practices on the Sunshine Coast, north of Brisbane, and has contracted to complete the acquisition in mid-January, 2012.

Located in Caloundra and Warana and separated by about 12 km, the two practices are modern and well equipped and have been established for many years. The Caloundra practice incorporates an on-site dental prosthetics laboratory. This will assist in delivering fast turnaround, efficient and economical dental prosthetic services to a broad patient base.

Although not financially material overall (given the scale of the company's established operations) these two practices and dental laboratory are strategically significant as they further complete the in-filling between other 1300SMILES practices in the area, creating further synergies, efficiencies, and economies of scale, along with added marketing and branding reach.

Upon completion, this will bring the total number of practices in South East Queensland to ten and the company overall to twenty-three.

## **OVERVIEW OF THE COMPANY'S BUSINESS**

The company provides comprehensive services in the areas of marketing, administration, billing and collections, and facilities certification and licensing to all participating dentists. The company also provides all support staff, equipment and facilities, and sources all consumable goods using the buying power which derives from such a large group of dental businesses.
