We write to you as a registered holder of the attached number of options as at 25 May 2012 as stated on the enclosed 'Notice of Exercise of Options' form. These options entitle you to acquire ordinary fully paid shares in Peninsula Energy Limited. Each option held is for the acquisition of one fully paid share, and the exercise price is three (3) cents per share.
