## AdEffective signs Footar Platform Licensing Agreement with EuroRSCG 4DMatrix

AdEffective Limited (**AdEffective** or the **Company**) is pleased to advise that a Technology Licensing Agreement (**TLA**) has been signed with EuroRSCG 4DMatrix (**EuroRSCG**). The TLA will provide EuroRSCG with a white label version of the Footar platform and technology.

Based in India and the United Kingdom, EuroRSCG is a digital marketing agency which houses core competencies in digital and new media. EuroRSCG is part of EURO RSCG Worldwide, one of the largest integrated marketing communications agencies in the world, made up of 233 offices located in 75 countries throughout Europe, North America, Latin America, Asia Pacific and the Middle East.

AdEffective will continue to invest in enhancing the Footar platform in the coming months to provide new and improved features to Footar.
