Magma Metals Limited – Appointment and Resignation of Directors

In regard to the composition of the Board of Directors of Magma Metals Limited ("Magma") (ASX: MMW), Panoramic Resources Limited (ASX: PAN) ("Panoramic") announces the following appointments and resignations of Directors.

As at close of business yesterday, the following persons were appointed to the Magma Board, being the new Non-Executive Chairman, John Rowe and new Directors, Christopher Williams and Trevor Eton. Vera Waldby was appointed as joint Company Secretary.

Immediately following these appointments, the outgoing Chairman, Max Cozijn, Managing Director Keith Watkins and Non-Executive Directors, Terence Burgess, Neil Fearis and David Constable tendered their resignations from the Magma Board.

The Board of Panoramic would like to thank the outgoing Directors for their efforts and contributions to Magma. It is anticipated that on Thursday, 28 June 2012, Magma will be officially delisted from the ASX platform following the successful Off-Market Takeover of Magma by Panoramic. Panoramic is now in the process of compulsorily acquiring the remaining shares in Magma and steps have been taken to delist Magma from the TSX platform in Canada.
