CALTEX AUSTRALIA LIMITED
BOARD AND ALTERNATE DIRECTOR CHANGES

Mr Richard Brown and Ms Barbara Burger have each been appointed as directors of Caltex Australia Limited (Caltex) with effect from 28 June 2012 to fill casual vacancies on the Board. The appointment of Mr Brown and Ms Burger follows the resignation of Mr Tim Leveille and Mr Walt Szopiak as directors of Caltex with effect from 27 June 2012. Mr Leveille has resigned following changes to his role at Chevron.

Mr Brown has over 30 years of oil industry experience with Chevron and has substantial financial and management expertise. He has recently been appointed as Regional Finance Officer – Asia Pacific, based in Singapore, with effect from 1 September 2012 and currently serves as Chevron's General Manager – Finance for Europe, Eurasia and Middle East Opco.

Ms Burger has served with Chevron for 25 years and has extensive experience in marketing, manufacturing and supply chain management. She currently serves as Vice President – Lubricants Supply Chain and Base Oil for Chevron Lubricants.

The Board has determined that Mr Brown and Ms Burger are not independent directors due to their service as executives with Chevron.

The Board has approved the appointment of Ms Colleen Jones-Cervantes as an alternate director for Mr Brown and Ms Burger with effect from 28 June 2012. As a result of Mr Leveille and Mr Szopiak's resignations, Ms Jones-Cervantes's appointment as alternate director for both of them automatically ends on 27 June 2012.
