Notice of Change of Interest of Substantial Holder

We refer to the Subscription Agreement between AGL Energy Limited (**AGL**) and Torrens Energy Limited (**TEL**) dated 8 July 2008 under which AGL has a top-up right (**Subscription Agreement**).

TEL announced in February that it had issued 10,560,484 ordinary shares in TEL to a sophisticated investor at \$0.05 per share. As a consequence of the issue of those shares, the voting power of AGL in TEL was reduced to 8.88%

AGL has exercised its top-up right under the Subscription Agreement and accordingly has subscribed to a further 1,172,084 ordinary shares in TEL, thereby increasing its voting power to 9.99%.

Please find attached a Form 604 notifying the change of interests of substantial holder. A copy of the Form 604 and this letter will be provided to the ASX in accordance with the requirements of the Corporations Act.

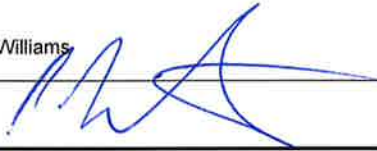
