Resignation of Chairman and Non-Executive Director

Wednesday, 25 July, 2012. The Board of Investorfirst Ltd (ASX: INQ) advises that Mr. Otto Buttula and Mr. Robert Bishop have resigned as a Chairman and Non-Executive Director respectively of the Company. The non-renounceable rights issue as announced on 20 July 12 remains unaffected, with the exception of updates required to take into account the above resignations.
