Actinogen Limited ("Company") - RESPONSE TO APPENDIX 4C QUERY

I refer to your letter dated 9 August 2012 regarding the Company's Appendix 4C announcement for the period ended 30 June 2012 and respond to your questions as follows:

1. It is possible to conclude on the basis of the information provided that if the Company were to continue to expend cash at the rate for the quarter indicated by the Appendix 4C, taking into account future administration costs, the Company may not have sufficient cash to fund its activities. Is this the case, or are there other factors that should be taken into account in assessing the Company's position?

This is not the case, and there are other factors that should be taken into account.

The Company is expecting to receive a payment from the Australian Taxation office in relation to a research and development taxation offset in the near future.

In times of limited funds the Company can implement policies to limit significant expenditures. This includes the suspension of director's fees and scientific research in order to conserve cash until decisions on fundraising can be finalised. The Company believes that given these factors it will have sufficient cash to fund its activities going forward. The Company is currently examining fundraising options.

2. Does the Company expect that in the future it will have negative operating cash flows similar to that reported in the Appendix 4C for the quarter and, if so, what steps has it taken to ensure that it has sufficient funds in order to continue its operations at that rate?

The Company does not expect to experience a negative operating cash flow similar to that reported in the Appendix 4C for the current quarter.

3. What steps has the Company taken, or what steps does it propose to take, to enable it to continue to meet its business objectives?

The Company has ceased all directors' fees except for those of Scientific Director Professor David Keast. Professor Keast is receiving a reduced salary of \$60,000.00 per annum until further funds are raised. If necessary, the company will suspend other significant expenditures including ongoing scientific research in order to conserve cash.







4. Can the Company confirm that it is in compliance with the listing rules, and in particular, listing rule 3.1?

The Company confirms that it is in compliance with the listing rules and in particular Listing Rule 3.1.

5. Please comment on the Company's compliance with listing rule 12.2, with reference to the matters discussed in the note to the rule.

The Company can confirm that it is in compliance with Listing Rule 12.2 and has sufficient assets to cover its liabilities and meet its ongoing commitments.

Actinogen Limited ("Company")

I refer to the Company's Quarterly Report in the form of Appendix 4C for the period ended 30 June 2012, released to ASX Limited ("ASX") on 27 July 2012 (the "Appendix 4C").

ASX notes that the Company has reported the following.

- 1. Receipts from product sales and related debtors of nil.
- 2. Net negative operating cash flows for the quarter of \$190,000.
- 3. Cash at end of quarter of \$204,000.
