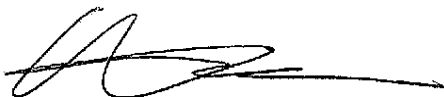
In addition to the voting power in ordinary shares disclosed in the attached Form 604, Kerogen also discloses the following in relation to options to be issued ordinary shares in AJL (**Options**). Each Option is in respect of one AJL ordinary share.

As a result of the exercise of 7,407,407 Options as announced to the ASX on 1 August 2012 and approved by shareholders of AJL on 5 September 2012, Kerogen now has the following interests in Options:

1. 7,286,996 Options owned by Kerogen; and
2. a right to re-purchase 3,872,360 Options held by Gleneagles Securities (Aust) Pty Ltd (**Gleneagles**) (see our letter dated 1 March 2012).

In Kerogen's notice of substantial holding in AJL given to ASX on 1 March 2012, CNOOC was disclosed as having a relevant interest in the shares held by Kerogen under section 608(8) of the *Corporations Act 2001 (Cth)*. CNOOC continues to be an investor in the Kerogen Fund but no longer has such relevant interest.

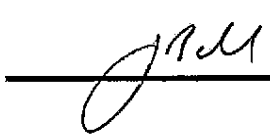

DIRECTIONS
