The Board would like to advise that in relation to Resolution 2, Adoption of the Remuneration Report for the year ended 30 June 2012 that the motion was carried unanimously by a show of hands and proxy voting was 89.9% for the resolution.

The Board also announces that Mr Bruce Loveday has been appointed as Chairman of the Company, following his election as director at today's AGM. A non-executive Director of Praemium since July 2012, Mr Loveday brings a wealth of Australian and international financial services experience.
