SCA PROPERTY GROUP (ASX: SCP) ASX ANNOUNCEMENT – SATISFACTION OF CONDITIONS FOR CONDITIONAL MARKET

SCA Property Group advises that implementation of the Distribution on the Implementation Date and allotment of the Stapled Units under the Offer (comprising the Woolworths Retail Shareholder Offer, the Broker Firm Offer, the General Public Offer and the Institutional Offer) on the Allotment Date (each as defined in the Product Disclosure Statement dated 5 October 2012) have occurred. The conditions for the conditional market have therefore been satisfied.

Trading from Wednesday, 12 December 2012 will be on an unconditional but deferred settlement basis until dispatch of initial holding statements has been completed, expected to be by Tuesday, 18 December 2012. Stapled Units are expected to commence trading on a normal settlement basis on Wednesday, 19 December 2012.

We confirm that the issued capital of SCA Property Group following the Distribution and issue of Stapled Units under the Offer will be 585,455,114 comprising the Distribution of 248,154,961 Stapled Units and the issue of 337,300,153 Stapled Units under the Offer.

Further to SCA Property Group's pre-quotation disclosure announcement on 26 November 2012, attached is a statement of the 20 largest securityholders (see Attachment 1) and a distribution schedule of the numbers of securityholders in the form contained in Appendix 1A, paragraph 48 (see Attachment 2) following settlement of the Offer.

The current number of securityholders with a parcel of stapled units with a value of at least \$2,000, based on the offer price of \$1.40, is 18,918.
