GREENCROSS LIMITED (ASX: GXL) Announcement Greencross Acquires Remaining 49% Interest in Greencross Vets Toowoomba Pty Ltd

Australia's largest veterinary group Greencross Limited ('Greencross' or 'The Company') is pleased to announce that it has entered into an agreement to acquire the remaining 49% of the issued capital of Greencross Vets Toowoomba Pty Ltd (known as 'GVT' or the 'acquisition').

After the completion of the acquisition the Company's total ownership in GVT will increase from 51% to 100%. The total consideration for the GVT shares equals \$997,390. The acquisition is expected to be earnings per share accretive in the 2013 fiscal year.

The consideration for the GVT shares is to be settled by the issue of 337,031 Greencross shares to the vendor. 194,031 of the Greencross shares issued to the vendor are subject to a voluntary escrow period of 1 year. The Greencross share issue price, being \$2.90 per share, was calculated by applying a 7.5% discount to the volume weighted average price of the Company's shares over the 25 business days up to and including 12 December 2012. This transaction is effective as of today the 14th of December 2012. Following is a copy of the Appendix 3B in relation to the issue of the new shares.

The vendor in relation to the GVT share swap is an existing employee of GVT. The share swap further aligns the GVT employee with Greencross as a whole. Furthermore, the vendor has entered into a 5 year Business Associate agreement in relation to one of the existing clinics owned by GVT, being the Greencross South Toowoomba Veterinary Clinic.
