Quarterly Cash Flow Report Highlights

Highlights of CogState's cash flow results for the quarter ended 31 December 2012:

- Net Operating Cash inflow of \$0.51 million for the quarter ended 31 December 2012.
- Recognised sales revenue of \$4.02 million for the December quarter, contributing to total cash receipts from customers of \$3.41 million for the quarter.
- Year to date cash receipts from customers were \$6.08 million, an increase of 23% compared to the December 2012 half year.
- \$6.80 million of combined cash and debtors at 31 December 2012:
 - Cash reserves of \$4.26 million (June 2012: \$4.66 million)
 - Trade debtors of \$2.54 million (June 2012: \$1.98 million)
- At 31 December 2012, current liabilities were approximately \$1.62 million (on par with the \$1.62 million at 30 June 2012).

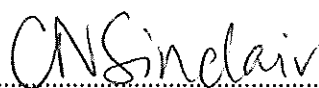
