Results of 2013 Extraordinary General Meeting for Cromwell Corporation Limited and Cromwell Diversified Property Trust

We advise that, at the 2013 Extraordinary General Meeting for Cromwell Corporation Limited and Cromwell Diversified Property Trust General Meeting held today, the resolutions to retrospectively approve the placements of Cromwell Property Group stapled securities to Redefine Australian Investments Limited and to other new and existing institutional investors that occurred in December 2012 were passed.
