Oil Business

Western Flank Oil Fairway (DLS 60% - Non-operated)

Drilling activity

No drilling took place during January 2013.

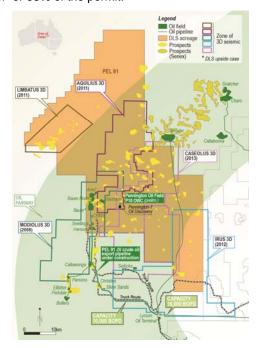
Appraisal and development activity

Field development work in the Bauer Oil Field Complex is ongoing with the installation, hydro-testing and commissioning of the Bauer-5 through 8 flowlines. Progress is continuing with the construction of the Bauer to Lycium pipeline, with a total of 38km of pipe installed since December 2012 and a further 9km remaining to be installed by the end of February 2013. Additional tie-in and pumping facilities are expected to be completed in April 2013.

The McKinlay pay zone in both the Bauer-2 and Bauer-4 wells was tested in January 2013 with dedicated production tests, which confirmed oil flow with no associated water production from sands of the McKinlay member.

Seismic activity

Seismic line preparation work began for the Caseolus 3D seismic survey which covers 485km² of the PEL 91 permit. It is estimated the seismic survey will be completed in June 2013. With the completion of the Caseolus survey PEL 91 will be covered by five 3D seismic surveys making up an area of 1,154km² or 58% of the permit.

Inland-Cook Oil Fairway (DLS 100% - Operated)

Drilling activity

Triclops-1, the first exploration well to be drilled in the Inland-Cook Oil Fairway, spudded on 14 January 2013 in ATP 539P. The main objective of the well was to test the hydrocarbon prospectivity of the Inland-Cook Fairway by demonstration of oil migration from the Yamma Yamma Depression into the Western Flank of the southwest Queensland Eromanga Basin. The primary targets of the Triclops-1 well were the Hutton Sandstone and sands of the Birkhead Formation. Although hydrocarbon shows were observed in the Westbourne Formation and the Adori Sandstone, quantities were not commercial. The well was plugged and abandoned after drilling to a total depth of 1,926 metres.

The Ensign Rig 918 was released on 31 January 2013 and will move 14km north east to the final well in the drilling campaign, Tibor-1, which is expected to spud in early February 2013.

Appraisal and development activity

No appraisal and development activity took place during January 2013.

Seismic activity

No seismic acquisition activity took place during January 2013 however ongoing interpretation continues.



Wet Gas Business

Western Wet Gas and Unconventional Fairway (DLS 50-60% - Non-operated)

Drilling activity

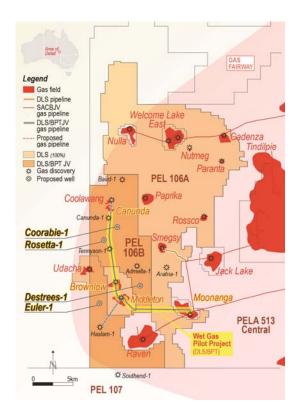
The second and third wells in a four well exploration campaign in PEL 106B (Drillsearch 50%) were spudded in January 2012. The Rosetta-1 and Destress-1 wells are located approximately six kilometres north and three kilometres east, respectively from Brownlow-1. Gas shows were encountered in each well, however reservoir quality associated with the shows was poor. With other good-quality sands water-saturated at these locations, the joint venture elected to plug and abandon both wells. The fourth and final well in the approved PEL-106B program, Euler-1, is scheduled to be drilled in June.

Appraisal and development activity

Construction of a gas gathering pipeline tying the Canunda Wet Gas Field to the Middleton Gas Plant was completed. Remaining tie-in facilities are expected to be completed by the end of March 2013.

Seismic activity

No seismic acquisition activity took place during January 2013 however ongoing interpretation continues.



Western Wet Gas and Unconventional Fairway (DLS 100% - Operated)

Drilling activity

No drilling took place during January 2013.

Appraisal and development activity

Site preparation began for the PEL 106A drilling campaign.

Two well locations have been identified with the first well to be drilled, Wamberal-1 expected to spud in February 2013 and the second well, Moruya-1 in March 2013.

Seismic activity

No seismic acquisition activity took place during January 2013 however ongoing interpretation of the Greater Andree Leleptian 3D seismic survey continues in conjunction with the reinterpretation of the Spinel 3D seismic survey

Northern Wet Gas Fairway (DLS 60-100% - Operated)

Drilling activity

No drilling took place during January 2013.

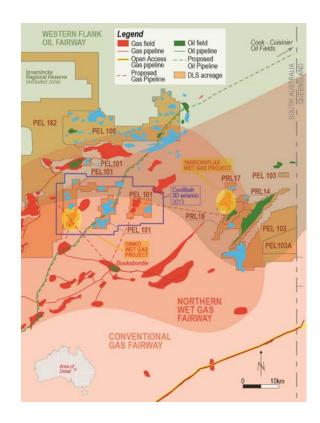
Appraisal and development activity

No appraisal and development activity took place during January 2013.

Seismic activity

Preparation work continued for the 478km² Coolabah 3D seismic survey which will cover PEL 101 (Drillsearch 60%) in its entirety. Scouting commenced in early January 2013 in advance of recording the Coolibah 3D seismic survey. Work area clearance has also commenced with native title claimants, the Yandruwandha and Yawarrawarrka People. The acquisition is expected to be completed early in the March quarter 2013.

An aerial survey was conducted by Fugro Spatial to acquire LiDAR across PEL's 101 and 103 and PRL's 14, 17 and 18. This will be followed by aerial photography and will provide accurate information for planning, and elevations for seismic processing.



Unconventional Business

Central Unconventional Fairway (DLS 100% - Operated)

Drilling activity

No drilling took place during January 2013, however, drilling is expected to begin in mid-2013.

Appraisal and development activity

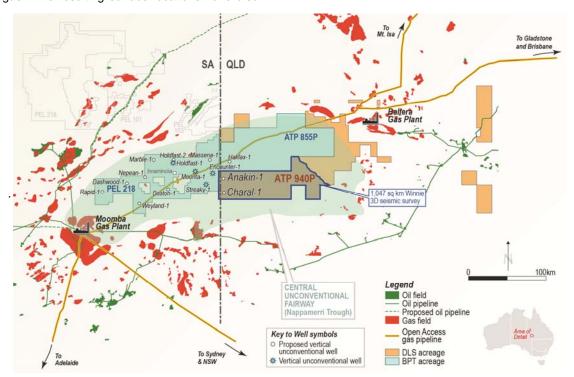
Drillsearch and Joint Venture partner QGC have agreed well locations for the first two wells in ATP 940P. The wells, Anakin-1 and Charal-1, have been based on 3D seismic to target multi-layered tight gas Patchawarra Sandstone and REM shale gas. The resulting surface locations have also

been optimised, following a field visit, to minimise surface operational risk and costs. Anakin-1 is due to spud in early June and Charal-1 in late August 2013.

Field activities will begin soon, including cultural heritage clearance, environmental approvals, well lease building, construction of a camp site, building of an access road and construction of a well pad lease.

Seismic activity

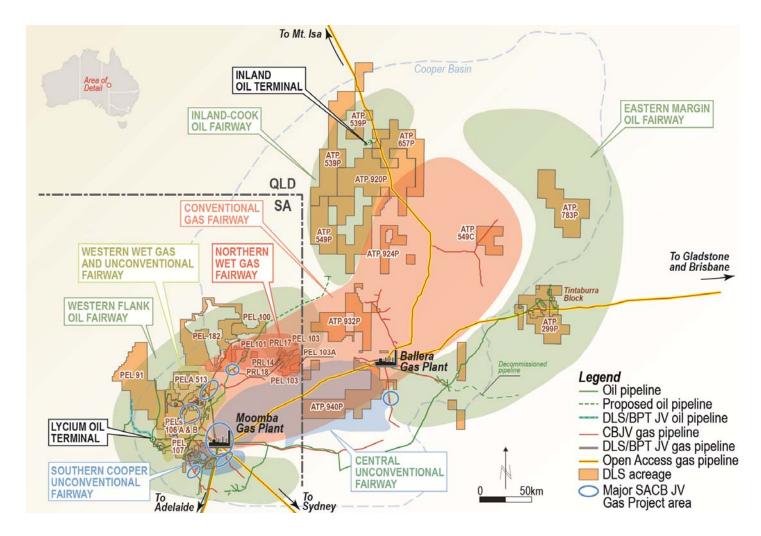
No seismic acquisition activity took place during January 2013 however ongoing interpretation of the Winnie 3D seismic survey continues.
