DIRECTORS' REPORT

Your directors present their report on Carpentaria Exploration Limited (the Company) and its controlled entities (the Consolidated Entity) for the half-year ended 31 December 2012.

OPERATING RESULTS

For the half-year ended 31 December 2012, the loss for the Consolidated Entity after providing for income tax was \$859,584 (2011: profit of \$1,600,636).

REVIEW OF OPERATIONS

Exploration

At Hawsons Iron Project, ongoing metallurgical work and permitting advances have been achieved during the period. An updated resource estimate has been delivered for the Yanco Glen Inferred Tungsten Resource and drilling at the Braemar Joint Venture intersected thick iron mineralization.

Hawsons Iron Project

During the half year, the Hawsons Iron Project was granted State Significant Development status and the Director General's Requirements for an Environmental Impact Statement were received from the New South Wales Government. This major step will allow Carpentaria to proceed with certainty towards a mining lease application.

A memorandum of understanding was signed with rail provider Genesee and Wyoming Australia Pty Ltd. for the transport of 5 million tonnes per annum (Mtpa) of magnetite concentrate with possible expansion to 20 Mtpa from a location near Broken Hill to near the port of Port Pirie.

Processing test work has continued with positive preliminary results indicating the assumptions used in the process flow sheet are reasonable. This work is ongoing.

Other work at Hawsons includes initiation of discussions with Transgrid, the electricity supplier, and ongoing environmental monitoring.

Other Projects

At the *Broken Hill tin/tungsten project*, following a drilling campaign last period, a revised Inferred Resource estimate has been established for the Yanco Glen tungsten deposit. The new resource has doubled the contained tungsten metal. Elsewhere, reconnaissance sampling for tin, tungsten and base metals was done.

At the *Braemar Joint Venture* a 500m reverse circulation drilling program was completed directed to discovery of Hawsons style magnetite siltstone mineralization. The results were positive with broad intersections of mineralization. This work also fulfilled Carpentaria's Stage one joint venture obligations. Iron mineralization was also confirmed at the *Torrowangee* project by one drill hole.

Carpentaria continued working on its gold portfolio, adding the *Tooloom* application and doing reconnaissance sampling at its *Barellan* licence. Elsewhere at *Temora*, access to land is awaited.



At the *Mt Agate Joint Venture*, where ActivEX is earning 75%, 1231m of reverse circulation drilling was completed following detailed soil and rock chip testing. Results are being assessed.

Rehabilitation work was completed at the Koonenberry nickel project.

Competent Person Statement The information in this report that relates to Exploration Results is based on information compiled by Mr Nick Sheard, who is a Fellow of the Australian Institute of Geoscientists and is a Registered Professional Geoscientist -Mineral Exploration and Geophysics. NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Reporting Entity

Carpentaria Exploration Limited (the "Company") is a company domiciled in Australia. The consolidated interim financial report of the Company as at and for the six months ended 31 December 2012 comprises the Company and its controlled entities (together referred to as the "Consolidated Entity").

Statement of Compliance

The consolidated interim financial report is a general purpose financial report which has been prepared in accordance with AASB 134 Interim Financial Reporting and the Corporations Act 2001. The Company is a for-profit entity for the purpose of preparing the interim financial report.

The consolidated interim financial report does not include all of the information required for a full annual financial report, and should be read in conjunction with the consolidated annual financial report of the Consolidated Entity as at and for the year ended 30 June 2012.

This consolidated interim financial report was approved by the Board of Directors on 1 March 2013.

Accounting Policies

The accounting policies and methods of computation applied by the Consolidated Entity in the consolidated interim financial report are the same as those applied by the Consolidated Entity in its consolidated financial report as at and for the year ended 30 June 2012.

New and revised standards have been issued by the AASB and are effective for the half-year; however there are no material changes to the policies that affect measurement of the results or financial position of the Consolidated Entity.

INDEPENDENT AUDITOR'S REVIEW REPORT

To the members of Carpentaria Exploration Limited

Report on the Half-Year Financial Report

We have reviewed the accompanying half-year financial report of Carpentaria Exploration Limited, which comprises the consolidated balance sheet as at 31 December 2012, and the consolidated statement of comprehensive income, consolidated statement of changes in equity and consolidated cash flow statement for the half-year ended on that date, notes comprising a summary of significant accounting policies and other explanatory information, and the directors' declaration of the consolidated entity comprising the disclosing entity and the entities it controlled at the half-year's end or from time to time during the half-year.

Directors' Responsibility for the Half-Year Financial Report
