Ottoway Engineering secures \$22.8 million new RAH Contract

Ottoway will be working directly for the Tier One Mechanical Contractor BSA Limited on behalf of design and construction partners Hansen Yuncken and Leighton Contractors Joint Venture (**HYLC**).

Ottoway will be responsible for the delivery of off-site fabrication and on-site mechanical, structural and piping installation which includes but not limited to the following:

- Prefabrication of chilled, heating and condenser water pipework;
- Fabrication of ring main piping modules;
- Installation of free issue plant;
- Supply and Installation of co-generation and boiler flues;
- Fabrication and installation of chilled, condenser and heating water risers; and
- Installation of fluid coolers, pipe work and platforms.

The Executive Chairman of EAL, Mr Stephen Young, advised that Ottoway was excited to be involved in the largest infrastructure and most advanced hospital project in South Australia's history.

In addition, Ottoway looked forward to developing its working relationship with BSA and HYLC on this project and was committed to delivering the contract works on time, on budget and in accordance with specification.

Off-site fabrication and manufacture associated with the project is planned to commence in April 2013, with on-site installation works scheduled to commence shortly after.

During the offsite fabrication stage Ottoway will engage approximately 25 personnel increasing to 50 once on-site construction commences.
