NEW USA FUNDING AGREEMENT

1. The Board of directors of IMF (Australia) Ltd ("IMF") is pleased to announce the funding of a further case in the United States by IMF's wholly owned subsidiary, Bentham Capital LLC ("Bentham").
2. As stated in our announcement of 17 May 2012, IMF has taken the policy position not to disclose specific details about Bentham's investments other than to describe them in a general manner until after resolution of each case.
3. This matter involves the funding of an attorney in a series of Federal and State cases involving claims for breaches of Federal and State False Claims Acts and also wrongful termination of employment.
4. IMF will include the claim value of this case in its Quarterly Investment Portfolio Reports as they are published.
