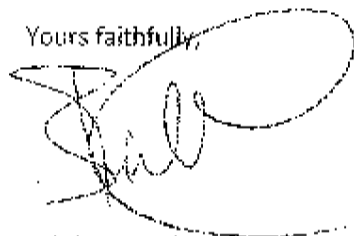

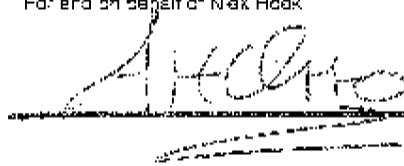

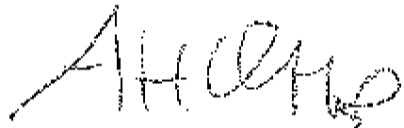
DIRECTIONS

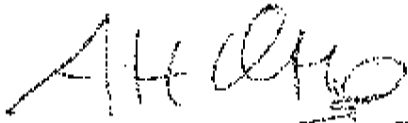
