MAGNOLIA LNG PROJECT APPROVAL PROCESS

The Directors of Liquefied Natural Gas Limited (*Company*) wish to advise that its wholly owned Magnolia LNG Project continues to maintain its permit and approvals Schedule through the Pre Filing process with the Federal Energy Regulatory Commission (*FERC*) with a target date to submit all 13 draft Resource Reports by November 2013.

Company Managing Director and Joint Chief Executive Officer, Mr Maurice Brand said that in accordance with FERC regulations, Magnolia LNG is required to submit a monthly report which is publicly released through the FERC web site.

"In addition, the Company will provide a general monthly update on the status of other relevant aspects of the Magnolia LNG Project as the Company drives towards a Final Investment Decision in early 2015", said Mr Brand.

Monthly Progress Report: No. 4 Period Ending: July 31, 2013

Introduction

By letter order dated March 20, 2013, Magnolia LNG, LLC ("Magnolia LNG") was granted approval by the Director of the Office of Energy Projects of the Federal Energy Regulatory Commission ("FERC" or "Commission") to utilize the Commission's Pre-Filing review process for the proposed Magnolia LNG Project ("Project"). The Commission's Pre-Filing review of the Project has been assigned Docket No. PF 13-09-000.

The proposed Magnolia LNG Project includes an 8 million tonne per annum ("mtpa") liquefied natural gas ("LNG") facility in the Port of Lake Charles, Louisiana, that will receive natural gas sourced from North America via an existing pipeline and liquefy, store, and deliver it as needed to LNG carriers for export overseas; LNG carriers and barges for domestic marine distribution and the possibility of LNG bunkering; and LNG trucks for road distribution to LNG refueling stations in Louisiana and the surrounding states. The Project will include four 2-mtpa LNG trains.

This Monthly Progress Report, which covers the period from July 1, 2013 through July 31, 2013, provides a brief summary of significant Project activities or changes in Project information that have occurred during the reporting period.

Filings with the Commission

No filings were made with the Commission during this period.

Agency Contacts

A Waterway Suitability Assessment ("WSA") workshop was held on July 8-10, 2013, in Lake Charles, LA, with the participation of the U.S. Coast Guard ("USCG"), the Port of Lake Charles, Calcasieu Parish Sheriff's office, Lake Charles Police, Lake Charles Pilots Association and various major users of the Calcasieu Channel (e.g. Trunkline LNG, BG, Citgo, etc.).

The FERC Scoping Meeting was held at 6:00 PM on July 11, 2013, at the Historic Cash & Carry building in Lake Charles, LA.

A conference call was held with the FERC on July 15, 2013, to discuss the scope of work proposed for the site specific seismic hazard evaluation and geotechnical investigations, which are scheduled to occur in August 2013.



A conference call was held on July 17, 2013, with the Environmental Resource Specialists of the U.S. Army Corps of Engineers, Mississippi Valley Division, New Orleans District ("CEMVN") to discuss the sampling and analytical requirements of future dredge spoil deposition in a Confined Disposal Facility ("CDF") managed by CEMVN and that may originate from the proposed Magnolia LNG Project.

Engineering

The following work was performed by CH-IV International (Technical Consultant) during the month of July 2013:

- Reviewed and provided comments on Process Flow Diagrams and Process Heat & Material Balances.
- Developed geotechnical field investigation program with Fugro, the Geotechnical Consultant.
- Commenced preparation of draft LNG storage tank specification and data sheet with Matrix PDM, the LNG tank contractor.

Environmental

The following work was performed by Ecology & Environment (Environmental Consultant) during the month of July 2013:

- Commenced air emissions inventory, air modeling protocols and air permit project work.
- Commenced background research and preliminary Resource Report development for: (a) Water Use Quality (Resource Report #2), (b) Fish, Wildlife and Vegetation (Resource Report #3), (c) Geologic Resources (Resource Report #6), (d) Soils (Resource Report #7) and (e) Air Quality & Noise (Resource Report #9).
- Worked with U.S. Army Corps of Engineers to define sampling and analytical requirements of future dredge spoil deposition.
