He has also held the General Manager Production Planning position for Woodside. Most recently he was Vice President Corporate Development and Upstream Commercial, including accountability for mergers and acquisitions. Matt will assume responsibilities for Strategy and Planning at Oil Search, with overall responsibility for commercial input and standards across the organisation.

Matt is a qualified accountant and has a Master's Degree in Business Administration. He will join Oil Search in January 2014.
