



**Sale of Securities in Sydney Airport**

**1. Introduction**

This Agreement sets out the terms and conditions upon which Abu Dhabi Investment Authority ("ADIA") engages UBS AG, Australia Branch ("UBS" or the "Underwriter") to dispose of 103,930,701 existing fully paid ordinary stapled securities in Sydney Airport (the "Issuer") (the "Sale Securities") held by ADIA (the "Sale") and the Underwriter agrees to procure the disposal of the Sale Securities and to provide underwriting thereof in accordance with the terms of this Agreement.

**2. Sale of securities**

**2.1 Sale.** ADIA agrees to sell, or procure the sale of, the Sale Securities and the Underwriter agrees to:

- (a) manage the sale of the Sale Securities by using best endeavours to procure purchasers for the Sale Securities at a price to be agreed, which shall not be less than A\$3.60 per Sale Security ("Sale Price"). Purchasers may include the Underwriter's related companies and Affiliates (as defined in clause 10.8) and may be determined by the Underwriter in its discretion; and
- (b) underwrite and guarantee the sale of the Sale Securities by purchasing at the Sale Price per Sale Security those of the Sale Securities which have not been purchased by third party purchasers (or the Underwriter's related companies or Affiliates) in accordance with clause 2.1(a) as at 10.00am (Sydney time) on the Trade Date (or such time as the parties agree in writing) ("Balance Securities"),

in accordance with the terms of this Agreement.

**2.2 Manner of Sale.** The Underwriter and ADIA will conduct the Sale by way of an offer only to persons:

- (a) if in Australia, who do not need disclosure under Part 6D.2 or 7.9 of the Corporations Act 2001 (Cth) ("**Corporations Act**"); and
- (b) if outside Australia, to whom offers for sale of securities may lawfully be made without requiring the preparation, delivery, lodgement or filing of any prospectus or other disclosure document or any other lodgement, registration or filing with, or approval by, a government agency (other than any such requirement with which ADIA, in its sole and absolute discretion, is willing to comply), as determined by the Underwriter in consultation with ADIA,

provided in each case (a) to (b) above that such persons may not be in the United States unless the Underwriter reasonably believes them to be QIBs or they are Eligible U.S. Fund Managers (in each case, as defined in clause 2.4).

**2.3 Effecting of Sale and settlement.** The Sale shall be effected on the Trade Date (as defined in the Timetable in Schedule 1), with settlement to follow on a T+3 basis in accordance with the ASX Settlement Operating Rules ("**Settlement Date**"). Subject to clause 9, on the Settlement Date, the Underwriter shall arrange for the payment to ADIA, or as ADIA directs, of an amount equal to the Sale Price multiplied by the number of Sale Securities less any fees payable under clause 3 by transfer to ADIA's account for value (in cleared funds) against delivery of the Sale Securities.

**2.4 U.S securities laws matters.** The Sale Securities shall only be offered and sold:

- (a) to persons that are not in the United States in "offshore transactions" (as defined in Rule 902(h) under the U.S. Securities Act of 1933 ("**U.S. Securities Act**")) in reliance on Regulation S under the U.S. Securities Act ("**Regulation S**"); and
- (b) to persons that are either (A) in the United States whom the Underwriter reasonably believes to be qualified institutional buyers ("**QIBs**"), as defined in Rule 144A under the U.S. Securities Act, in transactions exempt from the registration requirements of the U.S. Securities Act pursuant to Rule 144A thereunder or (B) dealers or other professional fiduciaries organised, incorporated or (if an individual) resident in the United States that are acting for an account (other than an estate or trust) held for the benefit or account of persons that are not "U.S. Persons" (as defined in Rule 902(k) under the Securities Act), for which they have and are exercising investment discretion, within the meaning of Rule 902(k)(2)(i) of Regulation S ("**Eligible U.S. Fund Managers**"), in reliance on Regulation S.

**3. Fees**

In consideration of performing its obligations under this Agreement the Underwriter shall be entitled to such fees as the parties agree.

**4. Undertakings**

**4.1 Restricted Activities.** ADIA undertakes to the Underwriter to not, prior to the Settlement Date knowingly commit, be involved in or acquiesce in any activity which breaches:

- (i) its constitution;
- (ii) the Corporations Act and any other applicable laws;

- (iii) the applicable listing rules of ASX Limited ("**ASX**"); and
- (iv) any applicable legally binding requirement of the Australian Securities and Investments Commission ("**ASIC**") or the ASX;

each of these undertakings being material terms of this Agreement.

## **5. Representations and Warranties**

**5.1 Representations and warranties by ADIA.** As at the date of this Agreement and on each day until and including the Settlement Date, ADIA represents and warrants to the Underwriter that each of the following statements is true, accurate and not misleading.

- (a) (**capacity**) ADIA has full legal capacity and power to enter into this Agreement and to carry out the transactions that this Agreement contemplates;
- (b) (**authority**) ADIA has taken all corporate action that is necessary or desirable to authorise its entry into this Agreement and its carrying out the transactions that this Agreement contemplates;
- (c) (**agreement effective**) this Agreement constitutes its legal, valid and binding obligations, enforceable against it in accordance with its terms;
- (d) (**ownership, encumbrances**) ADIA will transfer in accordance with clause 2.3, or procure the transfer of, the full legal and beneficial ownership of the Sale Securities free and clear of all liens, charges, security interests, claims, equities and pre-emptive rights, subject to registration of the transferee(s) in the register of shareholders of the Issuer;
- (e) (**no inside information**) ADIA does not, to the best of its knowledge and belief, possess any information that is not generally available and that a reasonable person would expect to have a material effect on the price or value of the Issuer's ordinary securities (other than knowledge that it proposes to enter into one or more transactions or agreements in relation to the Sale Securities pursuant to this Agreement);
- (f) (**control**) ADIA does not control the Issuer. In this clause 5.1(f), "control" has the meaning given in section 50AA of the Corporations Act;
- (g) (**power to sell**) ADIA has the corporate authority and power to sell the Sale Securities under this Agreement and no person has a conflicting right, whether contingent or otherwise, to purchase or to be offered for purchase the Sale Securities; and
- (h) (**US activities**) ADIA will not solicit any purchasers of Sale Securities in the United States and it will not advertise or announce the Sale in the United States.

**5.2 Representations and warranties of the Underwriter.** As at the date of this Agreement and on each day until and including the Settlement Date, the Underwriter represents to ADIA that each of the following statements is correct.

- (a) (**body corporate**) it is duly incorporated under the laws of the place of its incorporation;
- (b) (**capacity**) it has full legal capacity and power to enter into this Agreement and to carry out the transactions that this Agreement contemplates;

- (c) **(authority)** it has taken all corporate action that is necessary or desirable to authorize its entry into this Agreement and its carrying out the transactions that this Agreement contemplates;
- (d) **(agreement effective)** this Agreement constitutes its legal, valid and binding obligation, enforceable against it in accordance with its terms;
- (e) **(status)** it is a QIB or it is not a U.S. Person (which has the meaning given to that term in Rule 902(k) under the Securities Act);
- (f) **(no registration)** it acknowledges that the Sale Securities have not been and will not be registered under the U.S. Securities Act and may not be offered or sold in the United States except pursuant to an exemption from, or in a transaction not subject to, the registration requirements of the U.S. Securities Act;
- (g) **(no general solicitation or general advertising)** the Underwriter and each of its Affiliates and each person acting on behalf of the Underwriter or its Affiliates has not offered, sold, or solicited offers for or offered to sell, and will not offer, sell, solicit offers for or offer to sell the Sale Securities in the United States or to or for the account or benefit of any U.S. Person using any form of general solicitation or general advertising within the meaning of Rule 502(c) under the Securities Act or in any manner involving a public offering in the United States within the meaning of Section 4(2) of the Securities Act;
- (h) **(broker-dealer requirements)** all offers and sales of Sale Securities in the United States will be effected through the Underwriter's U.S. broker-dealer Affiliate;
- (i) **(no directed selling efforts)** with respect to Sale Securities to be offered and sold in reliance on Regulation S, the Underwriter and its Affiliates and each person acting on behalf of the Underwriter or its Affiliates have not engaged, and will not engage, in any "directed selling efforts" within the meaning of Rule 902(c) of the Securities Act and have complied and will comply with the offering restrictions requirement of Regulation S;
- (j) **(U.S. selling restrictions)** it, its Affiliates and any person acting on behalf of any of them has offered and sold the Sale Securities, and will offer and sell the Sale Securities:
  - (i) within the United States, either (A) to persons whom it reasonably believes are QIBs pursuant to Rule 144A under the Securities Act, or (B) to Eligible U.S. Fund Managers in reliance on Regulation S and has sold, and in each case will only sell the Sale Securities to such persons that have executed a confirmation letter; and
  - (ii) outside the United States, in "offshore transactions" (as defined in Rule 902(h) under the Securities Act) in accordance with Regulation S under the Securities Act; and
- (k) **(stabilization; manipulation)** neither the Underwriter nor its Affiliates nor any person acting on behalf of any of them has taken or will take, directly or indirectly, any action designed to, or that might reasonably be expected to, cause or result in stabilization or manipulation of the price of the Sale Securities in violation of any applicable law..

5.3 **Notification.** Each party agrees that it will tell the other parties promptly upon becoming aware of any of the following occurring prior to the completion of the sale of the Sale Securities:

- (a) any material change affecting any of the foregoing representations and warranties; or



- (b) any of the foregoing representations or warranties becoming materially untrue or materially incorrect.

**6. Indemnity**

6.1 ADIA agrees with the Underwriter that it will keep the Underwriter and its related bodies corporate and Affiliates, and their respective directors, officers and employees ("Indemnified Parties") indemnified against any direct losses, damages, liabilities, costs, claims, actions and demands (including any reasonably incurred and fully documented expenses but excluding any indirect, or consequential loss, punitive, special or exemplary damages or lost profit arising in connection therewith) ("Losses") to the extent that such Losses are incurred or made in connection with the Sale or as a result of a breach of this Agreement by ADIA, including any breach of any of the above representations or warranties given by ADIA.

6.2 The indemnity in clause 6.1 does not extend to and is not to be taken as an indemnity against any Losses of an Indemnified Party to the extent any Losses are finally judicially determined by a court of competent jurisdiction to have resulted from:

- (a) any penalty or fine which that Indemnified Party is required to pay for any contravention by it of the Corporations Act;
- (b) any amount in respect of which this indemnity would be illegal, void or unenforceable under any applicable law; or
- (c) the gross negligence, fraud or wilful misconduct of that Indemnified Party.

6.3 If the Underwriter becomes aware of any suit, action, proceedings, claim or demand in respect of which an Indemnified Party wishes to claim for indemnification under the indemnity contained in this clause 6, the Underwriter must promptly notify ADIA of the substance of that matter. The failure of the Underwriter to notify ADIA pursuant to clause this clause will not release ADIA from any obligation or liability which it may have pursuant to this agreement except that such liability will be reduced to the extent to which the amount the subject of the indemnity under clause 6.1 has increased, directly as a result of the failure to so notify..

**7. Announcements**

ADIA and the Underwriter will consult each other in respect of any material public releases by any of them concerning the sale of the Sale Securities. The prior written consent of ADIA must be obtained prior to the Underwriter making any public release or public announcement or engaging in publicity in relation to the Sale of the Sale Securities and such release, announcement or engagement must be in compliance with all applicable laws, including the securities laws of Australia, the United States and any other applicable jurisdiction.

**8. Confidentiality**

Each party agrees to keep the terms and subject matter of this Agreement confidential, except:

- (a) where disclosure is required by applicable law, a legal or regulatory authority or applicable listing Rules;
- (b) disclosure is made to an adviser or, in the case of ADIA, its client or to a person who must know for the purposes of this Agreement, on the basis that the adviser or person keeps the information confidential; and

- (c) to a person to the extent reasonably necessary in connection with any actual or potential claim or judicial or administrative process involving that party in relation to the Sale.

**9. Events of Termination**

**9.1 Right of termination.** If any of the following events occurs, then the Underwriter may terminate its obligations under this Agreement without cost or liability to itself at any time before 10 am (Sydney time) on the Trade Date by giving written notice to ADIA:

- (a) **ASX actions.** ASX does any of the following:
  - (i) announces that the Issuer will be removed from the official list of ASX or ordinary securities in the Issuer will be suspended from quotation;
  - (ii) removes the Issuer from the official list; or
  - (iii) suspends the trading of ordinary securities in the Issuer for any period of time.
- (b) **ASIC Inquiry.** ASIC issues or threatens to issue proceedings in relation to the Sale or commences, or threatens to commence any inquiry or investigation in relation to the Sale.
- (c) **Other termination events.** Subject to clause 9.2, any of the following occurs:
  - (A) **Banking moratorium.** A general moratorium on commercial banking activities in Australia, United States, the United Kingdom or the United Arab Emirates is declared by the relevant central banking authority in any of those countries, or there is a material disruption in commercial banking or security settlement or clearance services in any of those countries.
  - (B) **Breach of Agreement.** ADIA is in default of any of the terms and conditions of this Agreement or breaches any representation or warranty given or made by it under this Agreement.
  - (C) **Change in law.** There is introduced, or there is a public announcement of a proposal to introduce, into the Parliament of the Commonwealth of Australia or any State or Territory of Australia a new law, or the Government Australia, any State or Territory of Australia, or any Minister or other government authority Australia or any State or Territory of Australia, adopts or announces a proposal to adopt a new policy (other than a law or policy which has been announced before the date of this Agreement).

**9.2 Materiality.** No event listed in clause 9.1(c) entitles the Underwriter to exercise its termination rights unless, in the bona fide opinion of the Underwriter, it:

- (a) has, or would reasonably be expected to have, a material adverse effect on:
  - (i) the willingness of persons to purchase the Sale Securities; or
  - (ii) the price at which ordinary securities in the Issuer are sold on the ASX; or
- (b) would reasonably be expected to give rise to a liability of the Underwriter under the Corporations Act or any other applicable law.


**10. Miscellaneous**

- 10.1 **Entire agreement.** This Agreement constitutes the entire agreement of the parties about its subject matter and supersedes all previous agreements, understandings and negotiations on that matter.
- 10.2 **Governing law.** This Agreement is governed by the laws of New South Wales. Each party submits to the non-exclusive jurisdiction of courts exercising jurisdiction in New South Wales, and waives any right to claim that those courts are an inconvenient forum.
- 10.4 **Severability.** Any provision of this Agreement which is prohibited or unenforceable in any jurisdiction will be ineffective as to that jurisdiction to the extent of the prohibition or unenforceability. That will not invalidate the remaining provisions of this Agreement nor affect the validity or enforceability of that provision in any other jurisdiction.
- 10.5 **Waiver and variation.** A provision of or right vested under this Agreement may not be:
- (a) waived except in writing signed by the party granting the waiver; or
  - (b) varied except in writing signed by the parties. For clarity, this Agreement may be varied by the parties to it without the approval of any Indemnified Person.
- 10.6 **No assignment.** No party may assign its rights or obligations under this Agreement without the prior written consent of the other parties.
- 10.7 **Notices.** Any notice, approval, consent, agreement, waiver or other communication in connection with this Agreement must be in writing.
- 10.8 **Affiliates.** In this Agreement the term "Affiliates" means any person that directly, or indirectly through one or more intermediaries, controls, or is controlled by, or is under common control with, a person; "control" (including the terms "controlled by" and "under common control with") means the possession, direct or indirect, of the power to direct or cause the direction of the management, policies or activities of a person, whether through the ownership of securities by contract or agency or otherwise and the term "person" is deemed to include a partnership.
- 10.9 **Counterparts.** This Agreement may be executed in any number of counterparts. All counterparts together will be taken to constitute one agreement.


