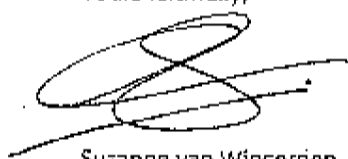

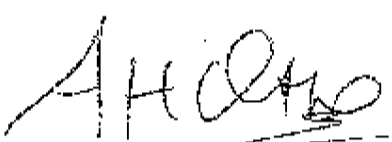
DIRECTIONS
