# RESULTS OF RESOLUTIONS CONSIDERED AT THE ANNUAL GENERAL MEETING HELD FRIDAY 25 OCTOBER 2013

Austal Ltd (ASX:ASB) held its annual general meeting on Friday 25 October 2013 at Fremantle, WA. In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act, set out below are the details of resolutions passed and proxies received in relation to each resolution in the Notice of Meeting dated 26 September 2013.

## 1. Resolution 1 - re-election of Mr. John Rothwell AO

Resolution 1 was carried at the meeting as an ordinary resolution by a show of hands.
