

# ASX ANNOUNCEMENT GROWTHPOINT PROPERTIES AUSTRALIA (ASX Code: GOZ)

### RIGHTS TRADING CONFIRMATION

Further to its announcement on 30 October 2013, Growthpoint Properties Australia ("**Growthpoint**") confirms that rights trading under its \$100 million rights offer is currently open. Rights are trading on the ASX as 'GOZR'. The rights trading period ends on Friday, 22 November 2013.

New stapled securities issued through the rights offer will initially trade as 'GOZN' and will receive a prorata share of any distribution for the half year ending 31 December 2013, calculated according to the time those securities are on issue during that period and currently expected to be 1.1 cents per stapled security. The issue price for stapled securities offered through the rights offer is \$2.45 per stapled security.
