Pirie 1 ST1 Weekly Drilling Report (Final)

Tellus Resources Limited (TLU or the Company) provides its final weekly update on the Pirie 1 well below. The well has now been cased and suspended as a potential Birkhead zone oil producer and the rig released on Saturday 9 November 2013.

As part of the farmin arrangement with Senex Energy Limited (Senex), the operatorship of PEL 105 is to be transferred from the Company to Senex. Interests in the block at this time and subject to Ministerial approval are:

TLU 50% Senex 50%

Senex has an obligation to drill a further well in the Permit by 30 June 2014 at its sole risk and cost. Following this, the interests in the block are to be:

TLU 30% Senex 70%

Commenting on the outcome of the Pirie 1 well, the managing director of TLU Carl Dorsch said that "Although the well did not reach its intended objective of the Tirrawarra sands due to multiple engineering and well bore problems, a successful sidetrack was managed. The decision to case and complete the well early was made by the Company as it gives access to the Birkhead which had good hydrocarbon shows. Although electric logs indicate poor sand quality there are cases in the Basin where good oil producibility is not picked up in logs. The Company is keen to test the zone and demonstrate whether an "unconventional" reservoir exists or not.

The well was drilled to the top of the Nappamerri to allow access to this zone. Gas has been found in this formation in nearby wells and may be investigated at a later stage if considered prospective.

No lost time accidents were reported for the well which was very pleasing given the difficult circumstances during phases of the program. I take this opportunity to thank the drilling contractor, subcontractors and representatives of the Company for their diligent efforts," he said.
