SYDNEY AIRPORT LIMITED – ADMISSION AND COMMENCEMENT OF OFFICIAL QUOTATION OF NEW STAPLED SECURITIES IN SYDNEY AIRPORT

Sydney Airport (the "Group") is a stapled entity comprising of a unit in Sydney Airport Trust 1 ("SAT1") stapled to a unit in Sydney Airport Trust 2 ("SAT2") ("Existing Stapled Securities"). The Group is undergoing a restructure whereby each unit in SAT1 and each unit in SAT2 will be de-stapled and SAT2 removed from the official list of ASX, and each unit in SAT1 will be stapled to one share in Sydney Airport Limited (the "Company")(the "Stapling Proposal").

After the implementation of the Stapling Proposal, the shares of the Company will be stapled to the units in SAT1 to form the new stapled securities (the "New Stapled Securities"). It is expected that the Company will be admitted to the Official List of ASX Limited on Tuesday, 26 November 2013.

Official quotation of the New Stapled Securities will commence at 10:09:00 am +/-15 secs A.E.D.T. on Tuesday, 26 November 2013 on a <u>deferred settlement basis</u>.
