Arena REIT – Stapling Proposal – admission to the official list of Sydney Healthcare Trust (to be renamed Arena REIT no 2) and the commencement of official quotation of Arena Group

On 1 November 2013, Arena Investment Management Limited announced a proposal to staple the existing listed entity Arena REIT (the "Fund") to Sydney Healthcare Trust (to be renamed Arena REIT no 2) (the "Trust") ("Stapling Proposal") to form an ASX listed stapled group ("Stapled Group").
