(a) Details of the dilution to existing holders of ordinary securities caused by the issue:

The Company issued 26,211,434 Ordinary Shares under Listing Rule 7.1.A, resulting in the following potential dilution to existing holders of ordinary securities:

- Number of Ordinary Shares on issue prior to 7.1.A securities issue (including those shares issued under Listing Rule 7.1): 301,431,484 shares
- Ordinary Shares issued under Listing Rule 7.1.A: 26,211,434
- Total Ordinary Shares on issue post 7.1A issue: 327,642,918
- Percentage of voting dilution: 8.7%

The Company considered the pricing (21.7% premium to the last trade prior to announcement) and the quality of the Subscriber (Pacific Road Capital are a resource specialist private equity fund) to present a benefit to all shareholders that would not be otherwise available under an entitlements issue to all shareholders.
